## Offering of Services

- · A natural breeding
- Side by side breeding with fresh semen to be placed vaginally or via TCI
- Shipped fresh semen via artificial insemination or TCI
- Shipped frozen semen via artificial insemination or TCI
- \*\* Females's owner shall be responsible for all expenses associated with shipping semen in addition to stud fee.
- \*\*Females's owner is expected to pay for their own Progesterone testing, Brucella Canis testing, and any breeding procedures.

# Repeat Breeding Policy

Stud owner does not guarantee any puppies will result from the breeding. Provided that if no puppies result from breeding, stud owner agrees to provide [one] repeat breeding to the same female (or other female owned and selected by females owners; that is approved by Stud owner). This would take place on the female's next heat cycle, if original breeding does not take.

## **Breeding Expenses**

Female's owner agrees to pay all expenses incurred for the purpose of the breeding at the time in which they are incurred, including, but not limited to: transportation of the female, all veterinary costs, artificial insemination costs, semen shipping cost.
